About 20% of District's operating budget comes from levies. Three different levies are up for renewal by voters (they will individually cover costs of classroom maintenance, technology upgrades, and busses). If passed, they will increase the homeowners' taxes slightly to compensate for growth in enrollment and aging tech.

VIS is Volunteers for Issaquah Schools and is the organization asking voters to approve the levies. VISvote.org is the website that is promoting the yes vote and provides information (along with ISF's website). From VIS's site, people can sign up to volunteer and/or donate to the passage of the levies.

Review of Minutes

<u>President's Report - Lynne Hickman</u>

- Introduced the PTSA's goals.
- Explained the differences between ISF (Issaquah School Funds) and the PTSA ISF covers the whole District while our PTSA covers only the needs of Discovery.
